Re: Freedom of Information Act Request

Dear Ms. Fairman:

This Freedom of Information Act request seeks production of:

- All public records including, but not limited to, all communications of any kind, type or form, such as written, digital, electronic (email), facsimile, audio, audio-visual, and internet (including via Skype, LinkedIn, Twitter, Facebook, Instagram, YouTube, WhatsApp, Messenger, WeChat, Tumblr, QQ, and other approved social media services used by the agency), that have been sent, dispatched and otherwise transmitted from, and/or received, collected, or held by, the U.S. Department of Interior Office of the Secretary (OS) (including the Office of Policy, Management and Budget (PMB) situated within it), from January 1, 2014 through March 18, 2020, concerning:
  - The possible transfer, before 1-20-25, by the U.S. Department of Interior Fish and Wildlife Service, or by the United States Congress, of the lands, wildlife, natural resources of, and/or the water rights to, the National Bison Range, one of the oldest units of the National Wildlife Refuge System, to the Confederated Salish and Kootenai Tribes (“CSKT”), a federally recognized tribe of the Flathead Indian Reservation located in northwestern Montana, to be held in trust by the Secretary of the Interior, acting as the trustee, for the benefit of the CSKT; *and*
  - The possible execution, before 1-20-25, by the CSKT, of an annual funding agreement (“AFA”) with the U.S. Department of Interior Fish and Wildlife Service, pursuant to the Indian Self-Determination and Education Assistance Act (P.L. 93-638) setting forth specific functions the CSKT would perform in operating and maintaining the National

Bison Range;<sup>1</sup> and

- The January 29, 2018 Settlement Agreement reached between the U.S. Department of Justice, Environment and Natural Resources Division, on behalf of the U.S. Department of Interior, U.S. Fish and Wildlife Service (FWS), and Public Employees for Environmental Responsibility (“PEER”) in D.D.C., Case No. 1:16-CV-00966-TSC.<sup>2</sup> (This lawsuit, filed in 2016, sought to enjoin the FWS from transferring the National Bison Range out of the National Wildlife Refuge System and into a trust held by the Secretary of the Interior for the benefit of the CSKT, without comprehensive National Environmental Policy Act (“NEPA”) or National Wildlife Refuge System Improvement Act evaluations having first been performed.)<sup>3</sup>

If you deny all or any part of this FOIA request, please cite each specific exemption upon which you based your denial of this request and/or refusal to produce and release the specific information sought, and notify
